**SUBMISSION RELEASE**

1. Grant of Rights: In consideration of including in the Film in the Handmade Puppet Dreams collection (the "Collection"), the undersigned ("you") hereby grant to Ibex, Inc. ("Ibex") the right and license to exhibit, copy, reproduce, encode, compress, edit, and publicly perform the Film in any and all media, manners and platforms, throughout the world, in and in connection with the Collection (collectively, the "Exhibition Rights"). The Exhibition Rights shall include, without limitation, the right to exhibit and/or screen the Film at festivals and film markets, as part of four-wall exhibition, etc. The Exhibition Rights shall continue from the date of this submission through December 31, 2012. You further acknowledge and agree that all physical elements submitted by you to Ibex shall become property of Ibex and will not be returned.
2. Use of Film for Marketing and Promotion: You understand and agree that Ibex shall have the right to use (a) the Film, all stories, puppets, characters, performances, name, likeness, music or sound in the Film (collectively, the "Element") and any portion, excerpt, screen shots of the Film, and any cut-in, photos of any puppets, stills, synchronized, dubbed or superimposed versions of the Film, all of the foregoing alone or together with other films and materials, juxtaposed with other films and materials in the Collection, etc.; and (b) any of the information you provide in this entry form, all in and in connection with the advertising, marketing and promotion of the Film, the Collection and/or Ibex, in any and media, manners and/or platforms (including, without limitation, the Internet), throughout the world, in any language and in perpetuity (collectively, the "Promotion Rights"). Notwithstanding the foregoing, any excerpt of the Film used by Ibex as provided in this paragraph shall not exceed 30 seconds.
3. Representation/Warranties: You hereby represent and warrant that (a) the Film is fully original to you; (b) nothing in the Film, none of the Elements, Ibex's exercise of the Exhibition Rights and/or Ibex's exercise of the Promotion Rights does or will violate or infringe on the rights or interests of any individual and/or entity, including, but not limited to, such individual's or entity's copyright, right of privacy and/or publicity; (c) you have the right, power and authority to grant Ibex the Exhibition Rights,

Promotion Rights and the permission of no other person or entity is required, or, in the alternative, you have identified to Ibex all other individuals or entities whose permission is required; and (d) you are over 18 years old. You agree to fully defend and indemnify Ibex from any and all claims, liabilities, costs and expenses (including attorney's fees) caused by, incurred from or related to a breach by you of any of the foregoing representations and warranties.

4. Credit/Compensation/Obligation to use: Except as necessitated for technical reasons, Ibex shall not alter any of the credits contained in the Film as submitted by you. You acknowledge and agree that Ibex may add any credit, title, or designation in connection with its exploitation of the Film and/or the Collection. You further acknowledge and agree that inclusion of the Film in the Collection and Ibex's exercise of its rights to the Film as provided herein shall not entitle you to any compensation and/or remuneration, and any payments made by Ibex to you, if any, shall be at Ibex's sole discretion. Ibex shall have no obligation to include the Film in the Collection or otherwise exercise any of its rights hereunder.
5. Misc. You acknowledge and agree that your rights and remedies in the event of any breach by Ibex of this agreement shall be limited solely to an action at law and in no event shall you have the right to enjoin or interfere with Ibex's exploitation of the Collection and/or rescind the Exhibition Rights or the Promotion Rights granted herein. You agree that Ibex shall have the right to transfer or assign this agreement and/or any of its rights or privileges hereunder to any person or entity. This agreement shall be governed by the laws of the State of California and you agree to submit to the exclusive jurisdiction of the Federal and State courts in Los Angeles County, California.
6. If accepted you will be required to submit your film in its highest quality format of original. If film, you must submit in Video format, uncompressed Quick Time format is the preferred method of delivery.
